Subject:- List comprising particulars of SDEs(T) promoted to the grade in BSNL during 2004-2007etc. –
Errors and Omissions – regarding

In order to prepare the seniority list of SDEs(T) promoted to the grade in BSNL after its formulation, a list (enclosed) comprising the name, category, Staff number, HRMS No, DOB, particulars of promotion order and the vacancy year in respect of seniority quota officers, who were promoted during 2004 to 2007 etc, has been drawn with a view to inviting errors and omissions.

2. The AIEL of JTOs circulated vide DoT letter No. 2-7/2003-STG-II dated 21.7.2004, which was employed by the DPC for promotion to SDE(T) in BSNL during 2004 to 2007, formed the basis for drawing this list. While preparing the list, it was noticed that in the AIEL dated 21.7.2004 the interpolation of JTOs in 1:1 ratio had been inadvertently done beginning with External candidates instead of Departmental Candidates in the Recruitment year 1990, 1991 and in 1992, thus rendering the Eligibility List imperfect. The arrangement of names in the "select panel" of officers recommended FIT for promotion by the DPC during 2004 to 2007 was set right by revised interpolation beginning with Departmental candidate instead of External candidate; however, it is noticed that even in the "select panel" the interpolation was done without including the names of officers from MTNL, thereby adversely affecting the initial inter se eligibility of Departmental and External JTOs. In the enclosed list, the interpolation of officers has been set right.

3. The vacancy year shown against individual officer in the enclosed list has been assigned based on the revised calculation of vacancies due to abolition of posts of SDEs (T). The revised vacancy positions was reported much after the initial DPC meetings for promotion to SDE(T) had been concluded in September, 2004 etc. Accordingly, the SDEs promoted on 16.9.2004, 25.1.2005, 8.8.2005 etc. had been re-allotted vacancy years 2002-03, 2003-04 and 2004-05 (part). This fact was intimated vide this office letter No. 26-1/2007-Pers-II dated 3.4.2007. The SDEs(T) promoted vide orders dated 15.3.2007 etc. have been allotted vacancy years 2004-05 and 2005-06. A few SDEs(T) have been assigned vacancy years 2006-07 and 2007-08 as per their date of appointment in JTO grade and their eligibility.
