Subject:- List comprising particulars of SDEs(T) promoted to the grade under seniority quota in BSNL against vacancy years 2006-07 to 2008-09 – Errors and Omissions – regarding

With a view to preparing the seniority list of SDEs(T) promoted to the grade under seniority quota against vacancy years 2006-07 to 2008-09, a list containing their particulars is enclosed for inviting objections therein.

2. The list is largely based on All India Eligibility List of JTOs circulated vide this office letters No. 2-18/2007-Pers(II)Pt 8.9.2008 and 2-18/2007-Pers-II dated 28.4.2010 that were used by the DPC for drawing the select panel for promotions to SDE(T). Subsequent changes in the aforesaid AIELs have also been incorporated in this List. The names of SDEs(T) have been arranged in the descending order of Recruitment year, Training marks, Training Attempts etc by interpolating the Departmental and External candidates in the prescribed ratio. The interpolation of officers between the two streams is not likely to be strictly in the prescribed ratio for varied reasons such as non implementation of promotion order, refusal of promotion, sealed cover cases etc.

3. The vacancy years indicated against individual officers is in accordance with the select panel recommended by the DPC.

4. The SDEs(T) promoted to the grade under competitive quota based on LDCE, 2012 for the corresponding vacancy years from 2006-07 to 2008-09 and 2009-10 will be circulated separately.

5. Circle office and all concerned are requested to go through the list and bring to the notice of this office any errors or omission in respect of Name, Staff No, HRMS No, Category, DOB etc with supporting documents through proper channel. Promotion Orders that have not been implemented due to refusal of promotion or pendency of disciplinary case or currency of penalty or any other reason may be reported separately. Direct representation received in this regard shall not be entertained.
