Reference is invited to this office circulars referred above vide which policy guidelines regarding provision of GSM mobile service connection to executives in BSNL were circulated. The policy has been further reviewed by competent authority of BSNL and revised free usage limit and additional facilities allowed to executives bellow JAG level as given bellow: -

All STS level officers or equivalent of BSNL.	One GSM mobile connection with STD and national roaming facility and usage limit worth Rs. 800/- per month.
All Grp B officers or equivalent of BSNL.	One GSM mobile connection with STD and national roaming facility with usage limit worth Rs. 700/- per month.

2. The existing instructions referred above stand modified to the extant mentioned herein above. Rest of the provisions of the existing instructions shall remain unchanged.
